Flagship Students: Are applying to TOSI Associate or Undergraduate Programs for the first time

I. Be 18 years of age or older

Exceptions are made for High School immersion programs, as well as University Integration and Inclusivity programs [with guardian consent].

II. Have a highschool diploma or the equivalency

III. No previous experience required (*Flagship Students only*)

A lot of our TOSI University students enroll with some form of experience in the Body Altering Aesthetics industry, but this isn't a requirement. Applicants may enroll without having had any prior experience. With TOSI University's outstanding teaching curriculum, **students are no longer required to have a medical background to enroll in our Flagship programs**. Students will learn proper anatomy and physiology, background medical foundations, and elite medical treatment applications all at TOSI University.

IV. Be able to commit to Program

The programs at TOSI range anywhere from 6 weeks to 12 months, depending on the program you choose to enroll in. Students are required to focus on ONE program or certification at a time. Dual enrollment is discouraged to allow students to fully commit to their program with precision and excellence. Review your chosen educational track to ensure you are able to fully commit and exceed the expectations set forth.

V. Prepare your Essay Question: (Flagship applicants will select 1)

- A. "Describe how joining the TOSI University community aligns with your academic and professional aspirations, particularly in the field of post operative science and innovation."
- B. Discuss the evolution of post-operative care practices in the last decade and critically analyze which advancements have had the most significant impact on patient outcomes.
- C. Explore the ethical dilemmas faced in post-operative care, particularly in relation to pain management, patient autonomy, and informed consent.

- D. Analyze how modern technology, such as telehealth and AI, is changing the landscape of post-operative care and its implications for patient care and recovery.
- E. Discuss the importance of an interdisciplinary approach in post-operative care, highlighting how different healthcare professionals contribute to successful patient outcomes.
- F. Examine the challenges and strategies for infection control in post-operative care, considering the impact of antibiotic-resistant bacteria and hospital-acquired infections.
- G. Evaluate the role of patient education in post-operative care and how it influences recovery rates, patient satisfaction, and overall health outcomes.
- H. Propose a quality improvement initiative for a post-operative care setting, detailing how it could improve patient outcomes, enhance efficiency, or reduce costs.
- I. "What unique perspectives or experiences would you bring to the TOSI legacy?"
